

2.1 Login System

Description	Administrator login to the system
Pre-Condition	Administrator account must be created
Post-Condition	Administrator was shown administrator panel after successful login.
Trigger	Administrator click on login.
Basic Flow	Administrator enters his user id and password to the textbox and click login. If information given is correct, administrator panel is shown. But if information given is incorrect system will show incorrect field given
Alternate Flow	Administrator forgets user id or password and clicks on forget password.

Basic Flow	Administrator to retrieve movie detail from then database and update any change on the field given. Changes will be saved to the database once administrator completed the update and click update.
Alternate Flow	Administrator clicks on back or cancel and the data inputted are not save into the database.

Use Case Name	Update session time
Description	Administrator updates all the session timing for the cinema.
Pre-condition	Administrator must login to the system.
Post-condition	Updated session time at the cinema will be available to all users.
Trigger	Administrator updates detail.
Basic Flow	Administrator will update session detail and input all detail to the required fields and save the session. Al fields should be input according to the field criteria. Any empty field or wrong input, the system wil prompt the administrator to review their input again.

Use Case Name	Promotion
Description	Administrator to create promotion mail and sent to all registered users.
Pre-Condition	Administrator must login to the system.
Post-Condition	Promotion detail will be sent to all registered users email address.
Trigger	Administrator click on send.
Basic Flow	Administrator to create the promotion email with all the promotion information as well as the random promotion code included to the mail to be sent to the registered users. When the administrator click on the send promotion button the system will communicate with the database to retrieve users email and send out the email.
Alternate Flow	Administrator cancels the promotion request to be sent to the users.
